

# Terms & Conditions

## 1. Definitions

- “Foundation”, “we”, “us” and “our” refer to Kshetri Welfare Foundation UK (KWFUK).
- “You” and “your” refer to any individual or organization accessing this website, applying for grants, or otherwise engaging with KWFUK.

## 2. Purpose & Activities

You understand that KWFUK is a charitable organisation, registered in the UK, whose purposes include:

- The promotion of social inclusion among Nepalese communities (and others) who are socially excluded on grounds such as race, ethnicity, religion, belief, immigration status, or financial hardship, via social, recreational, health-related, and cultural activities. ## 3. Eligibility & Beneficiaries

- Applicants for grants or aid must meet criteria as defined by KWFUK (as per grant application forms) and provide truthful information.

## 4. Membership, Applications & Use of Funds

- Grants are awarded based on submitted Grant Application Forms. Approval is at the discretion of KWFUK.
- Funds or material aid must be used for the purpose they were granted; any misuse may result in recovery or cancellation of aid.

## 5. Representations & Communication

- All information provided by you (in forms, communications) must be accurate.
- By contacting us or filling forms, you consent to communications via email, phone, or post using the contact details you provide.

## **6. Intellectual Property & Website Use**

- All content on the website (texts, images, logos) is owned by KWFUK or properly licensed. You may not reproduce, distribute or create derivative works without permission.
- You must not upload or transmit data that is illegal, harmful, or infringes others' rights.

## **7. Privacy & Data Protection**

- We will collect, store, and use personal data as needed to carry out our charitable activities, process memberships, grant applications, communications etc.
- We shall comply with applicable UK data protection laws.

## **8. Liability**

- KWFUK aims to provide accurate and current information; however, cannot guarantee that the site or services will be error-free or uninterrupted.
- KWFUK is not liable for any indirect or consequential losses arising from use of the website or services.
